# AFT WASHINGTON BYLAWS AMENDMENTS

# May 20, 2017

**Amendment 1:** To amend the Bylaws, Article III, Membership, Section 3, Affiliation Fees: Per Capita and Flat Rate, by increasing the income threshold for Category D from \$40,000 to \$45,000, and to apply a 6.9% increase to Categories C and D.

With the following proviso:

1. That the amendment will take effect on September 1, 2017.

A. A nomination and elections committee consisting of three (3) members, with no more than one member from a local, shall be appointed by the executive board after a call for nominees from AFT Washington local presidents, no later than the December board meeting of the year preceding the biennial convention.

Rationale: To give affiliate locals more time to appoint members to the Nominations and Elections Committee, without negatively affecting the convention timeline.

# May 20, 2017

Amendment 4: To amend the Standing Rules, Section 3, Per Capita Affiliation Fees.

With the following proviso:

2. That the amendment will take effect on September 1, 2017.

#### **Presently reads:**

- A. Category A: An employee earning less than
   \$10,000 per annual contract or in combined
   income for multiple terms in a year shall pay
   \$4.73 per month.
- 5 B. Category B: An employee earning \$10,000 or
  6 over, but less than \$20,000 per annual contract or
  7 in combined income for multiple terms in a year
  8 shall pay \$10.40 per month.
- 9 C. Category C: An employee earning \$20,000 or
  10 over, but less than \$40,000 per annual contract or
  11 in combined income for multiple contracts in a
  12 year shall pay \$21.74 per month.
- D. Category D: An employee earning \$40,000 or
  more per annual contract or in combined income
  for multiple contracts in a year shall pay \$28.36
  per month.

#### Will read if amended:

- A. Category A: An employee earning less than \$10,000 per annual contract or in combined income for multiple terms in a year shall pay \$4.73 per month.
- B. Category B: An employee earning \$10,000 or over, but less than \$20,000 per annual contract or in combined income for multiple terms in a year shall pay \$10.40 per month.
- C. Category C: An employee earning \$20,000 or over, but less than \$45,000 per annual contract or in combined income for multiple contracts in a year shall pay \$23.24 per month.
- D. Category D: An employee earning \$45,000 or more per annual contract or in combined income for multiple contracts in a year shall pay \$30.32 per month.

Rationale: To remain consistent with the proposed changes to the Bylaws, Article III, Membership, Section 3, Affiliation fees: Per Capita and Flat Rate, by increasing the income threshold for Category D from \$40,000 to \$45,000, and to apply a 6.9% increase to Categories C and D.
