Our eleventh year offering education scholarships!

Once again, the partnership of AFT Washington and the law firm Schwerin Campbell Barnard Iglitzin & Lavitt are offering \$1,000 education scholarships. Together, our organizations typically make available three or four \$1,000 education scholarships to eligible applicants who are AFT Washington members in good standing, or spouses, domestic partners, children, or dependents of AFT Washington members in good standing. Qualified applicants must plan to attend an institution of higher education during the 2016-2017 academic year. A scholarship committee reviews the applications for eligibility and determines the winners. Spelling and grammar count!

President's Column

Winter Turns into Spring

Together for Racial Equity and Justice” with **21 Progress, The Asian-Pacific Islander Coalition, Fuse Washington, Sound Alliance, Green River Community College’s Black Student Union, the Laborers Union International, WEA - Rainier Uniserv**, and others. The presentations and workshops revolve around organizing for equity and include telling our stories for change, student organizing for influence on campus, building solidarity around state budget priorities, workers’ rights, and more. Collective action is also a key part of the event.

We are working with partners who share our values and our goals for a more just, equitable society because we take very seriously the notion that we are **stronger** when **Standing Together**. Constituents of all of these groups contribute to their communities, just as our members do. Like you, they believe it’s time to reclaim the promise of the American Dream.

This presidential campaign season has made abundantly clear the competing visions for this country, just as the most recent legislative session did for our state. Whether they are proposals to build a bigger wall, weaken the safety net, undo anti-discrimination laws, suppress voter rights, or weaken collective bargaining rights, the threat to the promise of the American Dream is like a flashing neon light right in front of our faces. But these threats are not new, and we know how to fight back.

In the coming months we have our work cut out for us, and as I usually do, I urge you to join your AFT Washington sisters and brothers, along with our community partners, to take action for equity and justice. Here’s how:

- Build connections within your local community – with students & families, non-profits, human rights organizations – to achieve stronger communities.
- Participate in our political program to support the candidates who will fight on your behalf in the Legislature.
- Join our Legislative Affairs Committee to help shape our legislative agenda and strategize for success.
- Participate in our trainings to build your union leadership and organizing skills.
- Talk to fellow union members in your local – learn about each other and your needs and aspirations.
- Get involved in your local by attending a membership meeting and/or talking to your local’s officers.

The November election and 2017 legislative session are ripe with both potential threat and opportunity. By joining together now, we can influence the outcomes so that opportunities open up and threats are minimal. “We can” is not good enough, however. In fact, we must!

You may have noticed that you didn’t receive a Winter *Spotlight* as you usually do. During the last several months we have been fully engaged in our Powerful Locals Initiative, so we decided to delay our newsletter and invest all the time we could in engaging our existing members and reaching out to those who haven’t joined . . . yet.

I’m pleased to report that we have nearly 200 additional members as a result of our efforts. These are people represented by the union, but who hadn’t signed up to become a member. For some, they simply didn’t know they weren’t a member; for others, the benefits of membership – expressing a collective voice, voting, holding office, receiving great discounts – weren’t clear; and some had misconceptions about unions, not understanding our role as a mechanism for raising our collective voice at the bargaining table, in the Legislature, and in our communities.

Full engagement also means working with community partners to plan our second bi-annual Solidarity Event at Renton Technical College (you may receive this newsletter after it occurred. If so, I hope you were able to join us!) We are “Standing

Classified Council boosts professional development

For the fifth year in a row, the AFT Washington Classified Council planned and delivered professional development workshops on Saturday, March 12, at Giaudrone Middle School in Tacoma. Members came from United Classified Workers Local 4795, AFT Renton Classified Employees Local 6367, Tacoma Federation of ParaEducators Local 461, and Federation of Head Start Employees Local 6153. All together, 89 classified members attended the conference. The Tacoma Public Schools co-sponsored the conference by covering the cost of two presenters, which doubled the number of workshops offered.

Attendees could choose from workshops on Civility in the Workplace, Responding to Challenging Behaviors in Schools, Engaging Your Membership, Poverty: Understanding the Realities of Poverty so that Students Can Learn, and Using True Colors© to Understand Personality Types. These workshops were facilitated by qualified trainers in their fields of expertise.

After the workshops, **Maria Haynes** from TFP and chair of the Classified Council was the emcee for the afternoon. AFT Washington President **Karen Strickland** spoke about the importance of member engagement and building power to stand against anti-union attacks.

Last, but certainly not least, **Janet Watson** and **Beth DeCou** from AFT Renton Classified drew tickets for door prizes as everyone waited to see if they would be a winner. Several businesses donated items or gift certificates for the door prizes to show support.

The one critique, which was the first ever, is that they wish they had more time to cover the topic. This was true of every workshop. The Council will look next year at four-hour workshops for some of the trainings offered.

Fifth Annual North Puget Sound Conference on Race

Snohomish County - Community members concerned with social justice and human rights gathered on April 9 at the University of Washington Bothell Campus (UWB) for the Fifth Annual North Puget Sound Conference on Race; its theme: restorative justice. The free event was sponsored by the Communities of Color Coalition (C3) working in concert with representatives from numerous community groups and the UWB. As in prior conferences, the primary focus of the one-day race conference was to provide information and skills development that will help participants return to their communities better prepared to address issues of social justice and cultural and religious intolerance.

The American Federation of Teachers (AFT) Washington was invited to participate. Members **Tracy Lai** (AFT Seattle Community Colleges Local 1789 and AFT Washington board member) and **David Ortiz** (Cascadia Community College Federation of Teachers Local 6191) facilitated a lively discussion on how labor intersects with restorative justice efforts in both King County and in Washington State. Restorative justice is defined as a component of the criminal justice system that emphasizes the value of rehabilitation through a series of steps to help the offender transition back into their community. These efforts include reconciliation with both victims and the community as a whole.

Washington State's labor community can do more to help individuals transition away from the criminal justice system and back into society. In fact, AFT Washington has members who teach in the jails and prisons, as well as provide education and support for formerly incarcerated people. Assisting with job training and employment opportunities is critical in creating a labor force that is inclusive, diverse, and reflects the values of social justice and human rights.

Brotherly Love. **DuValle Daniel** (Shoreline Community College Local

1950 president) and **Kimberly McRae** (AFT Seattle Community College Local 1789 and co-chair of their Human Rights Committee) co-presented on the urgent need for faculty to organize in support of racial equity in hiring and retention throughout our colleges. **State Representative Gerry Pollet** (D-46) shared information and advice about getting favorable legislation passed in Olympia. Afternoon workshops then focused on building power at the local level through organizing, successfully filing and winning challenges for unemployment insurance benefits, and building ties with local

political and community movements.

AFT Washington's Contingent Faculty Issues Committee, chaired by Mike Boggess, helped coordinate the conference and hopes to hold a follow-up event in the fall.
