was still balanced on the backs of State employees.

There was one thing every legislator could agree on in Olympia and that was ending the session on time. Yes, getting out of Olympia as fast as possible only to get back to their districts to begin asking for campaign money for all the wonderful things that were accomplished in Olympia. Let the campaign kickoff begin!

One aspect of AFT Washington's legislative program is conducting "Legislative Education Groups (LEGs)." These meetings are set up to introduce our members to their respective representatives in their District to talk about our issues and essentially "educate" the legislator about our concerns and our values. Sometimes these meetings are held at larger venues, such as a college, but more often than not, they are small, intimate meetings at a coffee shop or a member's home. These private conversations are designed to have an honest, open dialogue with the legislator.

In a recent LEGs meeting with Speaker of the House **Frank Chopp** (D-43), AFT Seattle Local 1789 Co-President **Tracy Lai** said, "I was amazed how candid the Speaker was, he just spoke his mind; candid and honest."

### **Student Debt? There's Help!**

**I**f you or someone you know have federal student loan debt and are having trouble affording the payments, there are programs available to help you. There are several programs and they can (and should!) be used in combination.

The first and most important program to know is **Public Service Loan Forgiveness** which forgives the remaining balance on federal direct loans after 120 on-time repayments, which typically takes 10 years. Nearly all AFT members qualify for this program – educators from early childhood through higher education, healthcare workers including nurses, and anyone working for local, state, or federal government bodies. All it takes is a short form [https://studentaid.ed.gov/sites/default/ files/public-service-employmentcertification-form.pdf] to verify your employment. Payment you've made since 2007 will even count towards the 120-payment threshold – you could already be halfway there.

There are other student loan programs to reduce monthly payments [https:// studentaid.ed.gov/repay-loans/understand/plans/income-based] and loan forgiveness (https://www.studentaid. ed.gov/repay-loans/forgivenesscancellation/charts#perkins-loancancellation).

### Strong locals, leaders lay framework for Reclaiming the Promise

The strength of our union is in membership. And the most effective local unions have leaders and members who are knowledgeable and experienced about building strong locals, bargaining and defending strong contracts, and organizing new members around their issues.

AFT's Northwest Leadership Forum is one of the most effective events we have designed to help develop and support members and leaders. From **July 31- August 3** in Vancouver, Washington, AFT members from around our region will come together to have training on a variety of important topics.

These regional skills-based trainings are short courses on everything from Union 101 to Helping Ensure our Unions are Inclusive; hour-long seminars on Just Cause, a workshop on understanding the situation surrounding the well-funded attacks on unions, and a primer on assessing your leadership skills.

There are longer two-and-a-half day classes intended to help members and leaders learn to effectively strengthen and defend contracts, plan a contract campaign to build power and member engagement to support negotiations, and learn the tools and tips for effective communications, and more.

So mark these dates on your calendar and talk with your local leadership about registering to come. If a team from your local can attend a course together, you'll be able to take a plan home to implement with your newfound knowledge and the ongoing support of AFT Washington staff. Knowledge is power, and the confidence that comes from knowing what you are doing in potentially tough situations is an important tool in our collective tool boxes as union leaders. Connecting with other AFT members from around this region deepens our ties to the broader labor movement. All of these aspects of the Northwest Leadership Forum make this an experience you will want to be a part of. Come experience the forum!

**The legislative session is behind** us and it's time to gear up for this year's election cycle! Over the years, AFT Washington has consistently and relentlessly worked with our elected representatives and key policymakers to ensure that our voices are being heard in Olympia and in legislative districts across the state. We've fought for what's right. We've advocated for fully funding our education system from early learning through higher education, protecting our health benefits, respecting working families, and securing compensation options for our members.

And we've done so in the face of many obstacles – most notably the takeover of the State Senate by the Majority Coalition Caucus. In December 2012, two Democrats joined the Republican Caucus to take control of the Senate and began to block progress on issues our union cares deeply about. We saw good labor bills never get a vote. We saw bad bills come forward that threatened justice, fairness, and investments in our future.

But it doesn't have to be that way. It's through your efforts to call, write, testify, and meet with legislators that we've been able to defend against bad policies in Olympia, move the needle on issues we care about most, and build solidarity among our members and partners.

state Legislature that invests in strong communities, builds a strong workingclass economy, and creates a better future for Washington. This year that effort will come in the form of a newly developed political action program called "**Labor's Voice**."

In previous years, the Washington State Labor Council and its affiliates, including AFT Washington, have focused on a Labor Neighbor program that allowed all of us to communicate with union members across the state about endorsed labor champions.

This year, through Labor's Voice, we'll be able to communicate not only with our union members, but with general public voters as well. This maximizes our efforts and helps educate an even larger audience on why our endorsed candidates are the best choice when it comes to supporting working families, funding education, and building strong communities.

You are key to our success. To make sure these candidates make it to Olympia in January, we need to do more than cast our vote. We need to speak to each other and our neighbors about the best choices when it comes to championing those values in the legislative arena. We need you on the phones, at the doors, and in your locals helping to secure a government that works together with us to advance our shared priorities. We're counting on you to join us this year!

### Education Scholarships Available

The application process for the 2014-2015 AFT Washington/ Schwerin Campbell Barnard Iglitzin & Lavitt Scholarships is under way! At least two \$1,000 education scholarships are available to locals' members in good standing and their family members or dependents.

Our scholarships program began in 2006 when the principals of the Seattle-based labor law firm approached AFT Washington, asking us to partner with them to improve access to higher education and the awareness of labor rights among our members and their families. This is the ninth year of the cooperative program, with 27 students receiving scholarships thus far.

Qualified applicants must plan on attending an institution of higher education during the 2014-2015 academic year to earn a degree or credential at any level from associate to graduate.

The scholarship application must be received in the AFT Washington office **Friday, July 1, 2014**. Eligibility requirements, application guidelines, and the scholarship application form can be downloaded from our website at **wa.aft.org/scholarships**.

This strength, solidarity, and effective action will serve us well in the upcoming elections. For six years the majority of our members have gone without a cost-of-living adjustment and many have had practically no salary increases paired with higher healthcare costs. We've gained very little in the way of legislation and have had to fight back against bad legislation, largely due to gridlock in the Senate. The good news is that the labor and progressive communities have absolute clarity on what is needed and we are gearing up to take action to do just that.

With an AFT grant we will hire field representatives (see article on pg. 6) to reach out to get members involved – everyone loves a phone bank, right? Love it or not, it must be done if we want a State Senate that functions and supports working people like you and I. Please be ready to say "YES, I can help!" when asked.

This was our first Solidarity Event; our second will be in 2016. What it looks like will depend on you! We will select a local(s) interested in hosting events that will build solidarity within AFT, the labor community, and the local community. I invite you to be open to possibilities, talk about them within your local, and then let us know if you'd like to consider your town as a location. In the meantime, we have many books to distribute to kids who need them. If you'd like to hold a local event, talk with your local president and we will support your efforts.

Finally, I want to express my gratitude to all who participated in making our Solidarity Event a success – from staff, to local leaders, to member volunteers, to community organizations, to those who contributed money – thank you, thank you, thank you!

#### **Contingent Faculty Conference Features UI and National Organizing Efforts**

About 25 faculty attended the third annual conference for contingent faculty. For the first time, WEA contingent faculty members also joined them. It was a great way to build a connection across our unions as we deal with the same issues across the state.

The conference, planned with assistance from the Contingent Faculty Issues Committee, consisted of two half-day workshops, the first focused sharply on unemployment benefit issues, including the definition of reasonable assurance of employment.

#### Executive Director Marc Lampson

and Hearings Attorney **John Tirpak** from the Unemployment Law Project, along with WEA Lobbyist **Wendy Rader-Konofolski,** presented the background of our state's unemployment insurance law

for contingent faculty. They offered nuts-and-bolts advice about how to file and the process for appeals. The main message: don't give up!

The staff from the Unemployment Law Project made clear that they are available for ongoing support to help members get through this process. The group came up with some ideas about ways to not only support members who are applying, but also in pressuring the college administrations not to contest a faculty member's right to unemployment. The second half of the day was spent on organizing contingent faculty, and we learned about some strategies from other AFT locals. Alyssa Piccard, associate director of the AFT Higher Ed Department, shared the story of San Francisco City College Local 2121. Two years ago the Accrediting Commission for Community and Junior Colleges filed a report against the college that ultimately determined they would have to close their doors. This sparked a robust organizing campaign that would go on to unite students, Local 2121, other unions, and the community at large in the fight for their college.



Many members left this year's conference feeling inspired with new tips to boost their own membership numbers and with a renewed sense of urgency around tackling the issues.

#### Long-time union activist will be missed

Karen Toreson, a true friend of education, lost her ongoing battle with cancer on Sunday, March 30, 2014. A graduate of Eastern Washington University (EWU), Karen worked in education for 47 years, most recently teaching Business Technology as a tenured faculty member at Shoreline Community College. She started her teaching career teaching high school Business Education in Spokane and Seattle. After getting her Masters from EWU in 1973, she began teaching at the community college level. During her career she taught at Chemeketa Community College in Salem, Oregon; Bellingham Vocational Technical Institute; Edmonds Community College; and Everett Community College.



During her 27 years at Shoreline, Karen was the first faculty in her area to teach an online course and was instrumental in getting the Business Technology program online.

Karen was also passionate about her union. She served in a variety of positions including local president for six years beginning in 2002 and at the state level on the AFT Washington Executive Board from 2005-2013.
