Annual Meeting Highlights

The AFT Washington Retiree Chapter's annual meeting was held on May 19, 2018, at the IBEW Local 46 Hall in Kent, Washington.

Chapter board members confirmed at the annual meeting were Susan Levy, President; Glenda Hanson, Vice President; Carla Shafer, Secretary-Treasurer; Ross Rieder, Ann McCartney, Burt Weston, Directors. The E-Board welcomed Renee Potter and Debbie Dodd to fill vacancies on the E-Board as Directors. Thank you, John Guevarra, for your service.

We have \$2,480.70 in our AFT Washington account and \$901.38 in our voluntary account for a total of \$3,382.08 funds available.

We amended the Bylaws (Article V, Section 1 Officers) to allow the treasurer position to be combined with the secretary position.

We voted to support I-1631, a statewide initiative to the people that would charge pollution fees on sources of greenhouse gas pollutants. The membership's approval was conveyed to the Washington State Labor Council COPE Convention.

Resolution 2018-01 that addresses the retirement security crisis by supporting a bill in our Legislature to create a statebased, long-term care program was also approved.

Govenor Jay Inslee signed a bill that mandates that workers in Washington state be eligible for paid family medical leave funded by employee and employer contributions beginning in 2020.

Susan reported that attacks on Social Security are tracked by the Puget Sound Advocates for Retirement Action (PSARA) and suggested that we build an alliance with that group.

Annual Meeting Notes from Your E-Board

At the recent meeting of AFT Washington Retiree Board, I was pleased to see some newer faces and hear about some very creative plans for future AFT Washington retiree activities. What I saw and heard bodes well for the chapter's future.

Burt Weston

At our annual meeting, after introductions we received several reports. One of the reports focused on AFT Washington's legislative successes for our union, for labor, and for social justice issues. The collective bargaining law has been modified to allow salary to be bargained locally. The social justice issues include voting rights, Washington DREAM Act (which protects financial aid eligibility for undocumented students), help for schools to provide meals to disadvantaged students, ban on using income levels to discriminate against prospective tenants, other housing bills, and student loan bill of rights.

AFT Washington staff presented a report plus we heard reports from AFT Washington President Karen Strickland and Retiree Chapter President Susan Levy.

We approved two resolutions to be presented to the state convention. Resolution 2018-01 involves increasing retirement security for retirees. Resolution 2018-02 involves a pollution fee on sources of greenhouse gas pollutants to be used to provide jobs and promote clean energy.

We passed an amendment to the chapter's bylaws to streamline the administrative structure and we confirmed the officers to serve for the next year

After socializing over a catered lunch, a representative from the fraud section of the Attorney General's office gave a presentation on identity theft and scams directed at retirees.

We have several opportunities for our retirees to step up and get union-backed candidates in to office. Scamming Seniors Washington State Attorney General's Office

The guest speaker at our Annual Meeting was Elena G. Huizar, who is the Consumer Services Language Access Specialist in the Consumer Protection Division for the Washington State Attorney General's Office. Her work takes her all across the state, in an effort to inform LEP (Limited English Proficiency) and Englishspeaking communities of their rights as consumers and their rights and responsibilities as business owners in Washington. She was born and raised in eastern Washington and moved to the Seattle area in late 2014 with her two daughters. This year marks her tenth year with the Attorney General's Office. She discussed ways to recognize scams, report fraud, and protect ourselves and others from fraudulent activity. Three alarming statistics about senior scamming that she reported are:

1. According to a study by AARP, more than 50 percent of all fraud victims are seniors.

2. Seniors are less likely than other consumer groups to report becoming victims.

3. Consumer education can cut the risk of being victimized by more than 50 percent.

The Attorney General's office operates the Fraud Fighter Call Center along with the AARP Foundation to help consumers with tips on fraud prevention and what to do if victimized. Fraud prevention efforts are supported by a collaboration of many organizations including the Federal Trade Commission, the Washington State Department of Financial Institutions, the FINRA Investor Education Foundation, the Washington State Crime Prevention Association, the Better Business Bureau, and the U.S. Postal Inspection Service.
