Social Security and Medicare Are Still Vulnerable

We now have a split legislative branch in the federal government; Democrats control the Senate and Republicans control the House. For both, Social Security and Medicare will be front and center. First, the Republicans originally said they would not support raising the debt ceiling unless there were cuts to both Social Security and Medicare. They backed off that position after the uproar from Democrats, seniors, independents, and some Republicans. But the battle is not over.

It will not be an upfront battle but there are still threats to both programs in subtle ways. There are fears that Social Security and Medicare will both go broke. Solutions that are being discussed often include positions like raising the retirement age or creating more private Medicare options. These are cuts in disguise. We need to be vigilant in watching these two basic senior life support programs. And we must watch for and support programs that actually enhance Social Security and provide more Medicare benefits. Watch closely and let us know what you hear.

The Status of the Legislative Session and Ongoing Work

As part of the PEBB Stakeholders Medicare Coalition, AFT Washington Retirees have helped the HealthCare Authority plan the pilot Listening Session on Retiree HealthCare plans for Feb. 28th, with regular sessions running at least twice a week in March through May. SB 5169 to codify the HCA agreement to do this and save Classic UMP was heard in Senate Ways & Means, but failed to pass out of the committee; that bill has died.

HB 1057/SB 5350 (on a permanent COLA for the PERS/TRS Plan 1) has a lot of co-sponsors. It is still alive and making its way through the process.

Many of HCHR's Policy bills are moving along, including Safe (Continued on back)

Staffing. Keep Our Care died under corporate pressure in the Rules committee.

We had a quick response to a Senate Joint Memorial 8006 hearing to support asking the Administration and US Congress to act on 3 options on Universal HealthCare, including the federal waivers for states that Washington's Universal HealthCare Commission needs.

We met with newly elected WSLC officers April Sims and Cherika Carter. They plan to get a Labor dialogue going on Universal HealthCare after the session ends.
